Editing instructions

The papers will be written and edited according to the following specifications:

- title: Arial Narrow, bold, 16, capitals, center;
- authors: Arial Narrow, bold, 12, left;
- authors affiliation: Arial Narrow, 9, italic, left;
- summary: Arial Narrow, italic, 9, left, 100-150 words;
- key words: 4-6, Arial Narrow, italic, 9, left;
- text: Arial Narrow, size 11, line space: single, justified, **two columns text**;
- page setup: top 2,2 cm; bottom 2,2 cm; left 2 cm; right 2 cm; size A4; maximum 6 pages.

The papers will be written in **English**. The accepted papers will be included in the journals *Knowledge Horizons Economics*, *World Economy Journal*, *Global Economic Observer* quoted BDI*.
